1. Confidential Information

The Tenderer understands that all Tender Documents and other information, drawings, specifications, technical information and other material and data, whether written or otherwise, provided to the Tenderer (whether before or after the issue of the Invitation to Tender Letter) in respect of the Tender, the Subcontract Works and the Project, are confidential ("**Confidential Information**").

2. Undertakings

In consideration of the Confidential Information being made available by the Employer, the Tenderer agrees that, subject to clause 4 of this Undertaking:

- (a) the Confidential Information is and shall remain the property of the Employer;
- (b) it will use the Confidential Information for preparing its Tender and for no other purpose;
- (c) it will not disclose any Confidential Information to any person other than a person who is assisting the Tenderer in preparing its Tender (and the Tenderer shall ensure that person's adherence to this duty of confidentiality);
- (d) it will immediately return all Confidential Information to the Employer if the Tenderer declines to submit a Tender;
- (e) it will return all Confidential Information to the Employer' within 7 calendar days of being notified that the Tender was unsuccessful;
- (f) it will, and it will ensure that all other persons involved in the preparation of the Tender, only make contact with the Employer; and
- (g) it will immediately inform the Employer in writing on becoming aware of any breach of the terms of this Undertaking.

The Tenderer acknowledges that the Employer (or the person that prepared the Confidential Information) retains all intellectual property rights, including copyright, in the Confidential Information, and that none of the Tenderer or any of its officers, employees, representatives, consortium members, advisers, proposed subcontractors or suppliers shall be entitled to disclose or use the Confidential Information otherwise than in accordance with this Undertaking and the Instructions to Tenderers.

3. Indemnity

The Tenderer indemnifies the Employer from and against all damages, losses, liability, costs and expenses suffered or incurred by the Employer in respect of or in connection with any breach by the Tenderer of this Undertaking.

- (c) if required by any law of the Emirate of Abu Dhabi or any Federal law of the United Arab Emirates as applicable in the Emirate of Abu Dhabi, provided the Tenderer supplies the Employer with a copy of the proposed disclosure within a reasonable time prior to disclosure of the Confidential Information; or
- (d) if the Confidential Information is generally and publicly available other than as a result of breach of confidence by the person receiving the information.

5. Warranties

Neither the Employer nor any of their respective officers, managers, employees, representatives or advisers make any representation or warranty either express or implied as to the accuracy or completeness of the Confidential Information or as to the reasonableness of any assumptions which may be contained within it.

6. Governing Law
